SUBJECT: Hospitality Tax Advisory Committee Appointments

Purpose: The Hospitality Tax Advisory Committee is tasked with reviewing applications for hospitality funding and making recommendations to Council for the disbursement of those funds.

Composition: The committee is composed of eleven (11) individuals serving two (2) year terms with eligibility for one (1) re-appointment. The committee should consist of six (6) restaurateurs and five (5) at-large members.

Action: Council is asked to appoint one (1) individual to replace a resigning appointee. The current appointee represents an at-large seat. Council is asked to consider appointing Ms. Rosie Craig to the open seat and re-advertising the vacancy when Ms. Hardy rotates off this board in April.
