7. Council is asked to approve the Purchase of Two (2) Ford F350 Trucks with a Landscaping Body, as requested by the Parks and Recreation Department. Award to Dick Smith-Ford, using the SC State Contract in the amount of \$58,796.00. This vendor is located in Columbia, SC. *Funding Source: Parks-Buildings and Grounds/Auto, Trucks, Heavy Equipment-Capital; 1015104-658500 - **Note:** The original budget amount for the purchase of these replacement vehicles is \$60,000.00.*

(Protégé) located in West Columbia, SC., will provide design assistance, permitting assistance and construction inspection assistance at 26% of the contract value. The agreement includes evaluating the equipment and components, operating conditions, aesthetics, existing capacity and potential future capacity projections based on the service area that can be served by these pump stations. The original budgeted amount for this project is \$275,000.00.*

12. The scope of the project includes the evaluation of the Three Rivers Pump Station and the Colonial Life Pump Station including all equipment and components, operating conditions, aesthetics, existing capacity and potential future capacity needs based on the area that can be served by these pump stations. The original budgeted amount for the professional services portion of this project is ~~\$281,275.00~~ **\$285,000.00**. The implementation plan and scope was completed before the new MPP requirement of 20%. **The total subs for the project is 27% and is illustrated in the contract (exhibit D). The subs include Female, Small and Minority Business Enterprise firms.***

In accordance with Ordinance No.: 2004-094 – Amending the 1998 Code of Ordinances of the City of Columbia, South Carolina, Chapter 2, Administration, to add VI, Lobbyist, Sec. 2-302. (a) Any person who acts as a lobbyist must within fifteen days of being employed or retained as a lobbyist, register with the city clerk. (b) The registration must be in a form approved by the city council that includes only the name and business address of the lobbyist, the name and business address of the person or entity that compensates the lobbyist and the issue or matter for which the lobbyist has been retained. A separate form shall be submitted for each issue or matter and each person or entity who compensates the lobbyist. (c) Any lobbyist who is employed by the city or has contracts with the city must seek approval by city council to be a lobbyist for other clients so long as he is employed or under contract.
