Boil Water Advisory: Issued 10.28.15

The City of Columbia Water Works advises the water customers of **Chippewa Drive** located in **Richland** County, to vigorously boil their water for at least one (1) full minute prior to drinking or cooking. Also, any residents near the affected area who have lost water and/or water pressure are also advised to vigorously boil their water for at least one (1) full minute prior to drinking or cooking.

The City of Columbia has experienced a **four inch water main break**. This could possibly result in bacterial contamination of the water on **Chippewa Drive**. Water customers should continue to vigorously boil their water for at least one (1) full minute prior to drinking or cooking until otherwise notified by the City of Columbia Water Works. Also, any ice made from water that has not been boiled should not be used for drinking purposes.

The City of Columbia Water Works is presently working to correct the problem.

All food processors and restaurants should comply with prescribed USDA and SC DHEC recommendations, respectively. Should you have any questions pertaining to this advisory, please call the Lexington/Richland County Environmental Services at 896-0620. Restaurants and Hotels only may contact the SC Restaurant and Lodging Association at 765-9000.

Temporary Walk-up Flood Repair Stations at Washington Square

- The City of Columbia's floodplain office will be temporarily located in the Customer Service Lobby on the first floor of 1136 Washington Street. Staff will provide walk-up assistance to anyone needing to start flood repair work in the City. This service will be available during normal City business hours (M-F, 8 am-5 pm).
- The floodplain office will be set up in a series of stations to walk customers through the City's flood repair and rebuilding permitting process. Homeowners and contractors can learn whether their property is in a floodplain, pick up the permit application packet, determine their property value, have any questions regarding the application process answered, and submit their completed permit applications.

- Free 2 hour parking will be available in the nearby Washington Square Parking Garage on levels 2A and 2B for those seeking flood repair assistance.

Flood Damaged Property - Building Permit Information

- There are very important facts to be aware of before moving forward with any repairs to a flood-damaged home located in the floodplain. Taking steps without accurate information can cost time and money. Please see details below.
- Anyone making repairs to a flood-damaged structure in the City of Columbia needs to get a zoning and building permit from the Development Center. If using the service of a contractor, they must be licensed by the South Carolina Department of Labor, Licensing, and Regulation. Martin Luther King, Jr. Park Green Space Closed for Special Event Usage Only

The City of Columbia Parks and Recreation Department announced that the green space at Martin Luther King, Jr. Park is closed to special event usage due to the damage caused by the October 2015 Flood.

The park's community center remains open to visitors; however, all special events have been moved from the park until further notice.

All activities scheduled inside the community center will continue as normal.

The green space is still accessible for individual usage.

Riverfront Park to Remain Closed for Repairs

Riverfront Park, located at 312 Laurel Street, is temporarily closed to the public due to repairs that are needed after the October 2015 flood, the City of Columbia Parks and Recreation Department announced. The repairs are expected to take up to 30 days.

Utilities and Engineering Update

Canal Repair

- Canal rock dam construction is complete.
- Contractor continues working to address upstream bank stabilization. Expect repairs to continue at least through this week (week of Oct. 26).
- Anticipate raising water level the week of Nov. 2. Expected to take 24 hours to reach a normal pool of 148 ft. elevation (4-5 ft. below previous normal elevation). Reduction in level is due to less flow in the canal and the spillway being lowered during the event in an attempt to reduce flows and lower the water elevation during repairs.
- Contractor working at the headgates was authorized to begin fabricate the bulkheads for each gate. The bulkheads are a preventive measure to help control the flow into the canal should any of the gates fail. They began fabrication this week and anticipate beginning the installation by the end of next week. The anticipated completion of the bulk heads by Nov. 20 barring no issues.
- The Federal Energy Regulatory Commission inspected the Canal on Tuesday, Oct. 20, and Friday, Oct. 23. FERC will return the week of Nov. 2 when the water levels are raised.
- Bypass pumping continues and will continue until Canal levels can be raised, likely through the first full week of November. They will remain set up until the canal level is brought up and there have been a week or two of no pumping issues.

Water Plants

- The operation of the WTPs remains stable. The Canal WTP continues to rely upon the diesel driven pumps pulling from the Broad River and also from the Canal to deliver supply to the raw water reservoir. The operation of the distribution has returned to normal, as evidenced by the relatively equal finished water flow split between the plants.
- Lake Murray WTP – Normal operation. Pumpage for Oct. 29 (midnight to midnight) was 26 million gallons.
- Canal WTP – Pumpage for Oct. 29 (midnight to midnight) was 36 million gallons for raw water; 28 million gallons for finished water

- Covenant Road – Collapsed road caused a water main to fall Wednesday evening, Oct. 20. Break has been isolated. Chose to have City crews repair the break rather than using a contractor.
- Follow up repairs (all lines below have been isolated)
 - 12" Trenholm and Rockbridge – Had been previously isolated. Awaiting contractor bid for final repairs.
 - Overcreek – 6" broke in half at dam breach. Had been previously isolated. Awaiting contractor bid for final repairs.
 - 18" line break between South Beltline and Veterans – Had been previously isolated. Awaiting contractor bid for final repairs.
 - 6" at East Shore – Found the line laying in the creek. Was isolated before it was found. Awaiting contractor bid for final repairs.

Wastewater

- Metro Plant
 - The plant remains fully operational. Treated effluent flow for the previous 24 hr period was 49.1 million gallons. Average is 32 million gallons per day.
 - Influent flow for the previous 24 hr. period was 60.1 million gallons. Average is 43 million gallons per day. IPS wetwell level at 104.8 ft. elevation.
 - Equalization basin is at 119.27 ft. This is within the normal operating range; 115.5 ft. is empty. Max is 134-135.
 - Solids dewatering is running.
- Collection system
 - Pump Stations
 - Lift Station staff has returned to normal inspections and completion of standard SOPs
 - East Bluff Pump Station – Pump #2 remains out of service (pump sent to Flygt for repairs)
 - West Columbia Pump Station - Pump #3 remains out of service (pump sent to Flygt for repairs)
 - Saluda River Pump Station – Repairs to EQ tanks were completed.
 - Crane Creek Temporary Bypass System

- Last required pump was received
- Goodwin is onsite working on the connection piping
- Two pumps were set in place
- The 24” will be installed over Crane Creek this weekend provided that the water level in Crane Creek goes down
- The plan is to begin pressure testing the repaired force main next week
- Sanitary Sewer Overflows
 - SSO at 200 Candi Lane – Caused by Blockage in 42” interceptor. G.H. Smith is currently installing the bypass. It should be operational by this weekend.
- Location of Contractor Repairs:
 - Caughman Road Main Line Repair – Obtained invoice for repair from contractor.
 - Westwood Avenue Easement/Main Line Repair – Issue uncertain at this time. Seeking more information.
 - 110 Summerlea Drive Easement and Lateral Repair – Gills Creek relocated about 40’. WWM staff cannot currently access manhole. Gills Creek has relocated and washed out service line and easement access. Staff met with the home owner yesterday morning . The service line is currently discharging grey water and not domestic wastewater . We will need to set up a meeting with the City Engineer and U&E director to assess the situation and develop an action plan.
 - Crane Creek Barony Connection Repair - +/- 80 LF of 8” DIP aerial crossing was damaged. WWM staff currently by-passing. Assessed by engineering staff on 10-13-12. Aerial crossing damaged, but is currently being bypassed. Optional repairs are being considered. This crossing will be redesigned and bid.
 - 720 Rising Hopes Repair – Tree is located on 42” Gravity Sewer and creek has washed bedding away. Staff currently working on procurement package for this repair.
 - West Columbia 42” Interceptor Blockage/Repair –Bids were received on Monday. G.H. Smith Construction has submitted a construction schedule that indicates the bypass will be operational by the weekend
 - Gills Creek Manhole on 54” Near I-77 Repair – Manhole cone and riser section has been knocked over. Final repairs have been made.
 - 7645 Garner’s Ferry Road Repair – Approx. 60’ of aerial sewer lateral has been washed out. Site visit on 10-13-14. Sending location of service line to Real Estate Services to verify ownership.
 - Quail Creek Repair – Repair made by contractor – Obtained invoice for repair from contractor.
 - Reflections Repair – Repair made by contractor – Obtained invoice for repair from contractor.
 - 1400 Shop Road Blockage – 12” Lined gravity sewer over 15’ deep has a blockage – Emergency package is complete and distributed to bidders. This bid was held up due to finalizing procurement methods/documents. I will try to move this forward today. Bids scheduled to be received next week.
 - 320 Northwood St Point Repair – A section of 8” gravity sewer was determined to be damaged by WWM staff. The repair is on a very steep slope and WWM staff has requested contractual help to make the needed repairs. Staff is finalizing the procurement package
 - Various Erosion Control and Creek Crossing Repairs – U&E received a list of 13 locations

where gravity sewer system repairs are needed. We will be working with Contracts Administration to move forward with these repairs under a design build agreement.

 - The floodplain office will be set up in a series of stations to walk customers through the City's flood repair and rebuilding permitting process. Homeowners and contractors can learn whether their property is in a floodplain, pick up the permit application packet, determine their property value, have any questions regarding the application process answered, and submit their completed permit applications.
 - Free 2 hour parking will be available in the nearby Washington Square Parking Garage on levels 2A and 2B for those seeking flood repair assistance.
- Open Houses
 - City of Columbia flood repair assistance staff will also be joined by Richland County floodplain staff at the two off-site open houses later this week. Both City and County staff will answer questions about the flood repair process and hand out forms. Permit applications will not be accepted at the open houses. City permits can only be issued at Washington Square (1136 Washington Street).
 - Held first open house on Tuesday, October 13, 2015, from 6-8 PM at Bible Way Church's C.R. Neal Dream Center; estimated 50 people in attendance.
 - Held second open house on Thursday, October 15, 2015, from 6-8 PM at Kilbourne Park Baptist Church's Annie Green Building; estimated 100 people in attendance.
 - Two additional open houses held on Monday, Oct. 19
 - 5 p.m. to 6:30 p.m., Woodland Park; estimated 15 people in attendance.
 - 7 p.m. to 8:30 p.m., M.L. Smith Community Center; estimated 50 people in attendance
 - Additional open house in partnership with Richland County held on Thursday, Oct. 29 from 5:30 p.m. to 7:30 p.m. at Lower Richland High School; estimated 50 people in attendance.

 - City crews are working hard to identify and respond to any sanitary sewer overflows (SSOs) they can find. Anyone who sees damage to a manhole or signs of a SSOs should call 545-3300 and report it.
