




City of Columbia Incident Response Brief

Saturday, October 10, 2015

The following is a status update for the City of Columbia's incident response to the October floods. Timeframes are noted below for each section.

Water Distribution, Road Closure & Shelter Map

Water Buffalos (Water Filling Stations)

Residents will need to bring their own clean containers to the water filling stations between the hours of 9 a.m. and 7 p.m. until the boil water advisory is lifted.

- Customers can bring clean containers and fill from 250 gallon tanks delivered to above sites.
- National Guard providing security and on-site assistance at tanks.
- Water at these sites is being supplied by a water purification technology unit on loan from Water Missions International. Licensed drinking water plant operators from the South Carolina Water and Wastewater Response Network have volunteered to run this unit.
- FAQ:
 - Each Station will have elevated 275 gallon water tanks with valves on site.
 - This water is being provided by a reverse osmosis filtration unit. It has been tested and found to be safe to drink. Water Missions International and South Carolina Water and Wastewater Response Network are partnering with the City to supply and support this unit.
 - Stations will be set up and distributed at fire stations around the City of Columbia and filled by a water buffalo water truck.
 - “Please take what you need”
 - Stations will be monitored to provide enough water to each location.

Weather Update

- Cold front moving through Midlands until 2 p.m. which will produce thunderstorms and rain in the amounts from 1 to 2 inches, varying on location.

- Expected impact to the Midlands will include creeks and small streams, flooding possible.
- First Responders should be aware and be prepared for flash flooding in those areas, depending on the rain fall in previously affected areas as well as flood prone low areas. First Responders shall anticipate safety actions during this time period.
- No significant impact to the major river system.
- Caution should be exercised as the thunderstorms are producing lightning strikes as a precaution to our first responders.

Water System

- Canal breach
 - Repair
 - Continuing to move materials onto canal-side of the levy to stabilize the embankment. This will continue at least through tomorrow.
 - Still working on closure. Needed materials and equipment are being delivered, but the challenge is to place them on the berm side without destabilizing the site. It is a slow and tedious process.
 - Continuing to try and reduce the flow upstream.
 - Have adequate capacity in the canal to supply water plant.
 - Walking canal twice a day to look for further breaches. There are some signs of slope stability issues and sloughing further upstream that are being watched closely but are not presently a concern.
 - Bypass pumping
 - Began working on bypass pumping plan earlier this week.
 - Canal pumping - 5 bypass pumps are currently pumping water from the Canal into the Canal Plant. One to two additional pumps will be added Fri., Oct. 9 to provide additional supply
 - Broad River pumping – 2 pumps were installed and tested to draw from the Broad River and supply the Canal. Operation scheduled to begin this morning (Fri., Oct. 9). 3 more pumps were installed and awaiting testing. 4 more pumps installed, tested, and put into operation Fri., Oct. 9.
- Canal Water Treatment Plant
 - Plant production
 - Plant production is stable. Finished water quality is excellent and meeting standards.
 - Flow into reservoir is at 36 million gallons per day. Reservoir is currently FILLING.
- Lake Murray Plant
 - Stable and fully operational. Finished water quality is excellent and meets standards.
 - All distribution facilities for this part of the distribution system are fully operational
 - Bypass pumping
 - Began working on bypass pumping plan earlier this week.

- Canal pumping - 5 bypass pumps are currently pumping water from the Canal into the Canal Plant.
- Broad River pumping – Single 24" line is being pumped as of 4:30 a.m. Sat., Oct. 10. Additional 24" line and pump are being installed with some delay due to weather; anticipate completion within 48 hours.
- Supply line from Cayce put into service at approximately 9 p.m., Fri., Oct. 9 to add approximately 2 million gallons per day.
- CRFD has been using tanker trucks to assist in replenishing reservoir as well.
- Conservation message
 - Initiated water use minimization/ conservation message earlier this week.
 - Instituted a mandatory irrigation shut-off on Fri., Oct. 9, for all City water customers until further notice.
 - Declaration for large, non-critical water customers to curtail use until further notice is UNDER CONSIDERATION.
- Distribution System
 - All lines should be pressurized now. Any lines under repair should only be affecting pressure, not causing water outages. Some customers may be experiencing air pockets in their lines that make it look like they are out of water. Customer Care is advising them to open their cold water spigot for a couple of minutes to bleed the air. If water still does not run, they should then turn off the spigot and report it as an outage.

Wastewater System

- Metro Plant (no update available. Last update - Fri., Oct. 9)
 - The plant is fully operational. Producing fully treated effluent at 68 million gallons per day.
 - Equalization basin is at 129.5 ft. Max is 134-135. Influent wet well at 122.25 ft.
 - Plant returned to normal staff rotation on Sat., Oct. 10 using nearby dry farm field.
 - Out of dewatered sludge storage roll off boxes; storing sludge in the online digesters. Have plans to use offline digesters as sludge storage tanks if new boxes not delivered soon. Estimated 10 days of sludge storage at current wasting rates, although seeing signs that this level is increasing.
 - Coordinating with EMD to deliver these boxes.
 - Calculating at least 4 days of supply of all chemicals.
 - Seeing rising ammonia levels in plant before the storm. This is an indication of less flood water entering the system.
 - The collections system still appears to be taking in Inflow because the wwtp influent pumpstation remains inundated and the low manholes coming into the plant are overflowing due to the surcharge condition, operators are increasing the flow into the plant to aid these levels (currently influent flow – 72 million gallons per day).
- Collection system
 - Pump Stations
 - West Columbia Pump Station an additional pump was lost. Operating with 2 pumps; attempting to repair the second lost pump.
 - Lost connection with Saluda River Pump Station. Crews in route to check on status.
 - Bendale is flooded.
 - Harbison #4 is running at high level.
 - Staff will check control manhole for Saluda River Pump Station when the rain stops.
 - Sanitary Sewer Overflows
 - Multiple active overflows
 - Brickyard is underwater and overflowing.
 - Multiple manholes along Gills Creek overflowing.
 - Investigating other possible SSOs
 - Current assessment
 - Wastewater Maintenance has crews out today & tomorrow evaluating the system using CCTV & inspection of manholes & easements.

Boil Water Advisory

A boil water advisory is still in effect for most water customers in the City of Columbia.

- A partial appeal is in effect for the Town of Chapin, Ballentine, areas around Lake Murray Water Treatment Plant, Broad River Road, Lost Creek Drive and Chestnut Hills ([see map](#)).

Customers in the Town of Chapin, Ballentine, areas around Lake Murray Water Treatment Plant, Broad River Road, Lost Creek Drive and Chestnut Hills are no longer under a boil water advisory ([see map](#)) as of 6 p.m. on Wed., Oct. 7. **All other water customers are still under the advisory** and should follow the City's [drinking water advisory guidelines](#). In addition, city officials are asking citizens to continue minimizing water usage until further notice. By conserving water, residents will assist the City in protecting one of the region's main water sources while repairs are being completed.

The City of Columbia Water Works advises the water customers of the Chapin Area, located in Lexington and Richland County, along the following areas: Town of Chapin, Areas near the Columbia Lake Murray Plant. The southernmost boundary of this advisory is along Hwy 6 at the Lake Murray Plant, customers on Farming Creek Road, customers on Broad River Road down to Geology Circle. This notice is to inform customers in these areas that they no longer need to boil their water prior to drinking or cooking.

Following an intense flushing of the distribution system, bacteriological samples were collected and analyzed by the City of Columbia Water Works. The results of this sampling indicate that the system is safe to use for drinking and cooking purposes.

Voluntary Water Conservation

As the City works to stabilize water levels at the Columbia Canal, City officials are asking citizens to minimize water usage until further notice. By conserving water, residents will assist the City in protecting one of the region's main water sources while repairs are being completed. As a reminder, the system-wide boil water advisory is still in effect for all water customers.

 - 338sq mi searched
 - 281sq mi assessed for need

 - 2,095 civilians assisted
 - 11 pets rescued/sheltered with owner
 - **Responder Status Summary**
 - 3 Injured/Illness responders (Day 1)
 - 1 trapped/in need of rescue (Day 1)
 - All 4 were FF MAYDAYS (FF life or safety is in jeopardy & FF is unable to remove him/herself from threatening situation)
 - Responder returned to service next day
 - **Primary Materials or Hazards Involved (these hampered normal fire suppression coverage)**
 - Significant flooding in urban areas

 - Next 48hrs-Military assets/transport, USAR boat teams (SC Task Force 1), Mutual Aid Firefighting resources/Firefighter Mobilization assets
- **Planned Actions for Operational Period #11**
 - Transition operation back to CFD
 - CFD will provide safety & support for canal operations
 - Continue assisting hospitals with water needs (low water pressure)
 - Maintain normal CFD operations & provide increased presence in affected communities
- **Incident Management Team (IMT) Demobilization**
 - IMT transitional process back to CFD
 - CFD has requested multiple fire suppression assets through SC Firefighter Mobilization
 - Tankers throughout the State are being strategically placed in response areas due to lack of roadway access
 - Note-not for any city canal concerns

*Once all roadways are accessible Firefighter Mobilization will demobilize

Solid waste

- Storm debris collections started on Wednesday, Oct. 7. Will continue throughout weekend.
- Garbage collections normal service began Thursday, Oct. 8.
- Recycling pick-up on hold at least through this week (Oct 9). Will reassess for next week.
- Yard waste pick-up on hold at least through next week (Oct 15). Will reassess the following week.
- As a friendly reminder, per City ordinance, private contractors (i.e. landscapers, tree surgeons, construction) are responsible for debris and material removal at no expense to the City.
- Customers that need roll carts or assistance should call 545-3300. When City offices resume normal business hours, citizens can call 545-3800, Monday – Friday, 8 a.m.-5 p.m.

Flood Damaged Property - Building Permit Information

There are very important facts to be aware of before moving forward with any repairs to a flood-damaged home located in the floodplain. Taking steps without accurate information can cost time and money. Please see details below.

Anyone making repairs to a flood-damaged structure in the City of Columbia needs to get a zoning and building permit from the Development Center. If using the service of a contractor, they must be licensed by the South Carolina Department of Labor, Licensing, and Regulation. Do I have the green light to get a building permit for my flood-damaged property?



Green light: If your property is not located within the 100-year floodplain or is constructed at least two (2) feet above the base flood elevation, you will be issued a building permit for repairs that meet other applicable code standards (such as building and zoning).



Yellow light: If your property is located within the 100-year floodplain, before a building permit can be issued, it must first be determined through the completion of a Flood Hazard Permit Application:

- The elevation of the first floor of the property through submittal of an *elevation certificate*. (The City's Floodplain Manager may have one on file).
- If the structure sustained *substantial damage* or will require *substantial improvements* to make it habitable.



Red light: If your property is located within the floodplain and sustained *substantial damage* or will require *substantial improvements* to make it habitable, the structure will have to come into compliance with the City of Columbia's Flood Damage Prevention Ordinance. This means that the first floor of the building must be constructed at a height of two (2) feet above the base flood elevation. Please discuss how this affects your property specifically a City flood management representative.

What is *substantial damage*?

Substantial damage means damage of any origin sustained by a structure where the cost of restoring the structure to its before damaged condition would equal or exceed 50 percent of the market value of the structure before the damage occurred. (Note: the cost of repairs must include all costs necessary to fully repair the structure to its pre-damaged condition.)

What are *substantial improvements*?

Substantial Improvement means improvements of any origin where the cost of improving the structure would equal or exceed 50 percent of the market value of the structure before the improvements are made. (Note: the cost of improvements must include all costs necessary to fully improve the structure.)

What is an *elevation certificate*?

The *elevation certificate* is one way for a community to comply with the National Flood Insurance Program requirement that the community obtain the elevation of the lowest floor (including basement) of all new and substantially improved structures and maintain a record of such information. Elevation Certificates must be prepared and certified by a Licensed Land Surveyor, Registered Professional Engineer or Registered Architect who is authorized by state or local law to certify elevation information.
