#### Q: I want to annex into the City of Columbia. What do I need to do?

A: You just need to sign the petition. If you have questions you would like to have answered before you decide, please let us know at <a href="mailto:annexation@columbiasc.net">annexation@columbiasc.net</a> or 803-545-3217.

#### Q: How long will it be before the Garden Springs Neighborhood is annexed?

A: While it may be sooner, expect at least 8 months. The actual timeframe depends upon when enough owners sign the petition to qualify for annexation, which may take up to 6 months. Then, a public hearing must be held after a notice of at least 30 days. Once the public hearing is held, annexation is completed after City Council votes in favor of the annexation request on two separate occasions (called the  $1^{st}$  and  $2^{nd}$  readings).

### Q: Will I lose my Richland County Council representation?

A: No. All City of Columbia residents are County residents as well, and 10 of the 11 Richland County Council Districts are represented within the City limits. Garden Springs is within Richland County's Council District 11 – and represented by Councilman Norman Jackson.

#### Q: Will my school district change after annexation?

A: No. Garden Springs is served by Richland County School District One, which is separate from the City of Columbia. School district boundaries and attendance zones are set by the school district and do not change with annexation.

## Q: If annexed, when will my first tax bill that includes city taxes arrive?

A: The earliest you would pay the City of Columbia tax rate on a real estate tax bills would be January of the year following annexation. Taxes are due in January for the previous tax year. Tax bills are compiled and mailed before the end of the calendar year so some residents may not pay the City of Columbia Tax Rate until the second January following annexation.

# Q: What will annexation into the City of Columbia cost me?

A: There is no fee associated with the process of annexation. While each applicant's scenario is unique, the simple answer is that annexation saves MOST new City residents money, and a typical homeowner can expect savings of about \$400 a year when you consider all of the taxes and bills you pay.

- Taxes- Many are surprised to find that their in-city taxes are not as high as they think. And while you will pay both County and City taxes on a single bill, you may find that your bill actually goes down! This is because single family residences in unincorporated areas are assessed an annual \$249 solid waste fee that does not apply to properties within the City limits.
- **Bills-** Your water and sewer bills are less expensive in the City limits, though your electric and gas bills will go up slightly. Most other bills remain unchanged.
